Entry to BLS International Services Canada Inc., Indian Visa Application Centers (VAC):

1. Due to the limited size of VACs, attorneys (those accompanying applicants), relatives, drivers, or friends are not allowed in the VAC.
2. An applicant may however, bring one person to assist him/her if he or she is elderly, disabled, or a minor child.
3. Applicants should bear in mind that they may stand outside the facilities for their turn, please dress according to weather conditions on the day of your visit.

Important:

1. If you cannot visit the VAC, it is recommended that you use the postal service to submit your application.

3. Foreign visitors to Canada cannot apply for Indian visa services in Canada.

<input type="checkbox"/>	<p>Online Application Form:</p> <ul style="list-style-type: none"> - An Entry visa can be applied for six months or one year or five years. - Application must be completed and submitted online. - Visit: http://indianvisaonline.gov.in/visa/ and select 'Online Visa Application Registration.' - Be sure to select the correct Indian mission based on the place where you reside in Canada, and the mission's jurisdiction. - Mission jurisdiction can be viewed at: http://www.blsindia-canada.com/entryvisa.php - After submission online, no changes can be made. In case of an error, please register afresh online.
<input type="checkbox"/>	<p>Photograph:</p> <ul style="list-style-type: none"> - One photo of size 51mm x 51 mm. Paste this on Page 1 of the Application Form. - Photo must be compliant with specifications; refer to: http://www.blsindia-canada.com/photo_spec.php - You can avail of this service at the VAC; go to: http://www.blsindia-canada.com/vas.php
<input type="checkbox"/>	<p>Signatures:</p> <ul style="list-style-type: none"> - Sign at Page 1, inside the box, below your photo, and at Page 2. - Minor Applicants (Below 18 Years): <ul style="list-style-type: none"> o If minor can sign, signature must match with the valid passport. o If a minor cannot sign, using only black or blue ink, apply left hand thumb impression for boys & right for girls at Pages 1 & 2. o In this case, both parents must also sign below the applicant's signature, at Page 2.
	<p>Documents: Provide photocopies unless otherwise stated; attach the following valid documents in photocopies.</p> <ul style="list-style-type: none"> - Provide copies for all the documents on LETTER size paper. - All photocopies have to be self-attested <p>Address proof: A copy of 'address proof' must be attached with the application. It can be a copy of the utility bill, bank statement, rental Agreement, copy of Driver's license.</p> <p>References: Please ensure that references (both in India and in Canada) in Column (I) on page-2 of the visa application form are mentioned in full with name, complete address and phone number.</p>
<input type="checkbox"/>	<p>Canadian Passport (Original and copy of first page):</p> <ul style="list-style-type: none"> - Must be valid for at least 190 days. - Must have at least two blank/unstamped pages.
<input type="checkbox"/>	<p>Additional documents for Non-Canadian Passport:</p> <ul style="list-style-type: none"> - 'Additional Form to be filled by Foreign/Non-Canadian Nationals' – duly completed and signed. - Download at: http://www.blsindia-canada.com/entryvisa.php - Proof of work status in Canada: PR Card, Work Permit or Study Permit (photocopies)
<input type="checkbox"/>	<p>Additional documents for Former Indian National Applying for a Visa:</p> <ul style="list-style-type: none"> - Original and copies of: - Cancelled Indian passport - Landing paper - Surrender of Indian Nationality certificate (if issued by an Indian Mission). - If your Landing Paper indicates FC/Family category, provide a letter from the Refugee Board CIC indicating that you have never applied for a refugee status in Canada
