Entry to BLS International Services Canada Inc., Indian Visa Application Centers (VAC):

1. Due to the limited size of VACs, attorneys (those accompanying applicants), relatives, drivers, or friends are not allowed in the VAC.
2. An applicant may however, bring one person to assist him/her if he or she is elderly, disabled, or a minor child.
3. Applicants should bear in mind that they may stand outside the facilities for their turn, please dress according to weather conditions on the day of your visit.

Important:

1. If you cannot visit the VAC, it is recommended that you use the postal service to submit your application.

3. Foreign visitors to Canada cannot apply for Indian visa services in Canada.

<input type="checkbox"/>	<p>Online Application Form:</p> <ul style="list-style-type: none"> - A Volunteer visa may be approved for up to 6 months and is valid from the date of issue. - Application must be completed and submitted online. - Visit: http://indianvisaonline.gov.in/visa/ and select 'Online Visa Application Registration.' - Whilst completing your online application, a drop down menu will offer you a choice of visas; be sure to select: 'Employment.' - Be sure to select the correct Indian mission based on the place where you reside in Canada, and the mission's jurisdiction. - Mission jurisdiction can be viewed at: http://www.blsindia-canada.com/volunteervisa.php - After submission online, no changes can be made. In case of an error, please register afresh online. - Once done, print your form, put your application and documents together, and submit it to BLS.

Paste this on Page 1 of the Application Form. - Photo must be compliant with specifications; refer to: http://www.blsindia-canada.com/photo_spec.php - You can avail of this service at the VAC; go to: http://www.blsindia-canada.com/vas.php
<input type="checkbox"/>	<p>Signatures:</p> <ul style="list-style-type: none"> - Sign at Page 1, inside the box, below your photo, and at Page 2. - Minor Applicants (Below 18 Years): <ul style="list-style-type: none"> o Signature must match with the valid passport. o If a minor cannot sign, using only black or blue ink, apply left hand thumb impression for boys & right for girls at Pages 1 & 2. o In this case, both parents must also sign below the applicant's signature, at Pages 1 & 2.
	<p>Documents: Unless otherwise stated, attach the following valid documents in original:</p> <p>Address proof: A copy of 'address proof' must be attached with the application. It can be a copy of the utility bill, bank statement, rental Agreement, copy of Driver's license.</p> <p>References: Please ensure that references (both in India and in Canada) in Column (I) on page-2 of the visa application form are Mentioned in full with name, complete address and phone number.</p>
<input type="checkbox"/>	<p>Canadian/Foreign Passport:</p> <ul style="list-style-type: none"> - Must be valid for at least 190 days. - Must have at least two blank/unstamped pages.
<input type="checkbox"/>	<p>Non-Canadian Passport:</p> <ul style="list-style-type: none"> - 'Additional Form to be filled by Non-Canadian Nationals' – duly completed and signed. - Download at: http://www.blsindia-canada.com/volunteervisa.php - Proof of work status in Canada: PR Card or Work Permit (photocopies).
<input type="checkbox"/>	<p>Sri Lankan Passport/Person of Sri Lankan Origin:</p> <ul style="list-style-type: none"> - If you hold a Sri Lankan passport: <ul style="list-style-type: none"> o 'Additional Form to be Filled by Sri Lankan Nationals/Origin' – duly completed and signed.

Such documents must be less than 6 months old. - Applicant's resume.
	<p>Minor Applicant (Below 18 Years):</p> <ul style="list-style-type: none"> - Minor Consent Form: <ul style="list-style-type: none"> ○ Duly completed and signed by both parents. ○ Download at: http://www.blsindia-canada.com/entryvisa.php - Passports: both parents (Copies). - Both parents to sign at Page 2 of scanned copy of online Volunteer visa application. - Minor travelling without parents: <ul style="list-style-type: none"> ○ Notarized Affidavit indicating consent to travel. Both parents to sign. - If either parent is out of the country whilst applying, that parent to provide the following in addition: <ul style="list-style-type: none"> ○ Minor Consent Form – duly completed and signed. ○ Notarized Affidavit indicating consent to spouse to travel with minor. ○ Notarized photocopy of passport from Notary Public. ○ Sign at Page 2 of scanned copy of online Volunteer visa application.
