Entry to BLS International Services Canada Inc., Indian Visa Application Centers (VAC):

1. Due to the limited size of VACs, attorneys (those accompanying applicants), relatives, drivers, or friends are not allowed in the VAC.
2. An applicant may however, bring one person to assist him/her if he or she is elderly, disabled, or a minor child.
3. Applicants should bear in mind that they may stand outside the facilities for their turn, please dress according to weather conditions on the day of your visit.

Important:

1. If you cannot visit the VAC, it is recommended that you use the postal service to submit your application.

3. Foreign visitors to Canada cannot apply for Indian visa services in Canada.

<input type="checkbox"/>	<p>Online Application Form:</p> <ul style="list-style-type: none"> - Transfer of visa may be approved from an old to a new passport, provided the visa has a residual validity for more than 1 year. - Application must be completed and submitted online. - Visit: http://indianvisaonline.gov.in/visa/ and select 'Online Visa Application Registration.' - Be sure to select the correct Indian mission based on the place where you reside in Canada, and the mission's jurisdiction. - Mission jurisdiction can be viewed at: http://www.blsindia-canada.com/transfervisa.php - After submission online, no changes can be made. In case of an error, please register afresh online. - Once done, print your form, put your application and documents together, and submit it to BLS.

<input type="checkbox"/>	<p>Non-Canadian Passport:</p> <ul style="list-style-type: none"> - 'Additional Form to be Filled by Non-Canadian Nationals' – duly completed and signed. - Download at: http://www.blsindia-canada.com/transfervisa.php - Proof of work status in Canada: PR Card or Work Permit (This should be valid for at least 6 months). - Proof of address in Canada: Driver's License, Bank Statement or Utility Bill (The latter two must be less than 6 months old).
<input type="checkbox"/>	<p>Former Indian National Applying for a Transfer Visa for the First Time:</p> <ul style="list-style-type: none"> - Cancelled Indian passport. - Surrender of Indian Nationality certificate. - Landing Paper. - If your Landing Paper indicates FC/Family category, provide a letter from the Refugee Board CIC.
<input type="checkbox"/>	<p>Minor Applicant (Below 18 Years):</p> <ul style="list-style-type: none"> - Minor Consent Form – duly completed and signed by both parents. - Download at: http://www.blsindia-canada.com/transfervisa.php - Minor travelling without parents: <ul style="list-style-type: none"> o Notarized Affidavit indicating consent to travel. Both parents to sign. - If either parent is out of the country whilst applying, that parent to provide the following in addition: <ul style="list-style-type: none"> o Minor Consent Form – duly completed and signed. o Notarized Affidavit indicating consent to spouse to travel with minor.
