Please check the 'Sample Form' available on [www.blsindia-canada.com](http://www.blsindia-canada.com) for assistance on filling up your application. Kindly carry a copy of this checklist while submitting your application.

### Entry to BLS International Services Canada Inc., Indian Visa Application Centers (VAC):

1. Due to the limited size of VACs, attorneys (those accompanying applicants), relatives, drivers, or friends are not allowed in the VAC.
2. An applicant may however, bring one person to assist him/her if he or she is elderly, disabled, or a minor child.
3. Applicants should bear in mind that they may stand outside the facilities for their turn, please dress according to weather conditions on the day of your visit.

### Important:

1. Applicant must visit personally to BLS Centers to apply for 10 years visa, kindly note in order to get 10 years visa Bio metrics is compulsory.
2. 10 years visa will not be accepted by Post/mail, applicant has to visit BLS centers.
3. Alternatively, to book a pickup and/or drop via FedEx, visit <http://www.blsindia-canada.com/vas/>
4. Foreign visitors to Canada cannot apply for Indian visa services in Canada.
5. **The duration of the visa is subject to approval by the Consulate General of India, Toronto.**

This can be obtained from <a href="https://www.blsindia-canada.com/forms/HCI-CGI_Minor%20consent%20form.pdf">https://www.blsindia-canada.com/forms/HCI-CGI_Minor%20consent%20form.pdf</a></li> <li>- Valid Passport photocopies of both parents</li> </ul> <p><b>- For Minor travelling without parents;</b></p> <ul style="list-style-type: none"> <li>- Notarized Affidavit indicating their consent to travel. Both parents need to sign on the affidavit.</li> <li>- Passport photocopy of the person travelling with the minor.</li> </ul> <p><b>- If either parent is out of the country that parent has to provide:</b></p> <ul style="list-style-type: none"> <li>- Original Notarized Affidavit indicating consents to spouse to travel with minor.</li> <li>- Original Notarized passport photocopy of second parent who is abroad from Notary Public.</li> <li>- Original copy of online visa application duly signed at Page 2</li> </ul>

(Work permit has to be valid for at least 6 months)</li> <li>- Landing Paper of spouse</li> </ul> <p><b>In case spouse has acquired Foreign citizenship provide below documents too.</b></p> <ul style="list-style-type: none"> <li>- Surrendered Indian passport of spouse</li> <li>- Surrender of Indian Nationality certificate of spouse (if issued by an Indian Mission).</li> <li>- Landing paper of spouse.</li> </ul> <p><b>Note:-</b>If Landing Paper indicates/Family category, provide a letter from the Refugee Board CIC indicating that you have never applied for a refugee status in Canada. (You may apply for the Refugee Board letter by emailing <a href="mailto:atip@irb-cisr.gc.ca">atip@irb-cisr.gc.ca</a> )</p>
<input type="checkbox"/>	<p><b>Proof of address in Canada:</b></p> <p>Driver's License, Bank Statement (Stamped from the bank) or Utility Bill (The latter two must be less than 6 months old). For minor, one parent proof of address is required.</p>
<input type="checkbox"/>	<p><b>Bio metrics:</b></p> <p>Applicant must provide their Finger prints and photo, applicants below the age of 12 years and above 70 years are exempted.</p>
