Be sure to select the correct Indian mission based on the place where you reside in Canada, and the mission's jurisdiction. Mission jurisdiction can be viewed at: http://www.blsindia-canada.com Please note: Online applications are only accepted if filled out in the current year. Please fill the online application form based as per your passport. After submission online, no changes can be made. In case of an error, please fill a new online application form. Please note: BLS International employees cannot edit or make any changes to your online application form.
PHOTOGRAPH SPECIFICATIONS: - Two Photographs of size 51mm x 51 mm. Paste one on Page 1 of the Application Form. - Photo must be compliant with specifications; refer to: http://www.blsindia-canada.com/photo_spec.php - You can avail of this service at the VAC. Additional documents for Former Indian Nationals: - Surrendered Indian passport (first and last page copy) - Surrender of Indian Nationality certificate (if applicable) - Landing paper with immigration category. Note: In case, original landing paper is not available or lost, a duplicate true copy (for eg- 'Status of Verification' document from CIC), clearly reflecting the immigration category can be submitted.
Business Documentation: Please provide the following letters on Company's letter head reflecting the Company's name, address, name of the sponsor, telephone number, web address, email address and financial sponsorship arrangements - Letter from the applicant's Company in Canada stating credentials of the applicant and purpose of travel to India. - Letter of Invitation from Company in India indicating the applicant's purpose for business visa, applicant's current employment details, duration of stay and places,/ companies to be visited in India.
