- 2. 5-10-year visa applications will not be accepted by post/mail.
- 3. Foreign visitors to Canada cannot apply for Indian visa services in Canada.
- 4. The duration of the visa is subject to approval by the Consulate General of India, Toronto.
- 5. The Consulate reserves the right to call for additional documents, if necessary.

7. Proof of address in Canada:  - Driver's license, Ontario ID card, utility bill (less than 6 months old)  - For minor applicant, one parent's proof of address is required.
8. Bio metrics: (Applicable for applicants between the age groups of 12 and 70) Finger prints and photograph of the applicant will be taken at the VAC.
