Requirements:

1. Application, including Personal Particulars form, duly completed with specimen signatures.
2. Four passport size (3.5 cm x 3.5 cm) photographs- frontal view against white background.
 - The photograph must be a full-face front view facing the camera directly
 - Face should cover about 60-70 percent of the photo area
 - The photograph MUST be in color and have only a white background. Photos with dark, busy, or patterned backgrounds will not be accepted.
 - The applicant's head, including both face and hair, should be shown from the crown of the head to the tip of the chin. The ears, neck, and shoulders must be visible.
3. Existing Passport in original and photocopies of its relevant pages.
4. Work Permit/Study Permit/Immigration status and PR Card in original and copy/ies thereof.
5. Proof of Address (Photocopy of Driver licenses, Bank Statement or utility bill) for Toronto Jurisdiction only.
6. If the application is sent by mail a prepaid self-addressed envelope from Fed-EX or Express Post is to be sent along with the application.
