In case of joint POA/Affidavit/Document, all signatories have to fill Misc service form and should provide self attested copies of all supporting documents.
- These two sets (original and copy), along with the required fee, can be presented to the BLS Centre by the executants) and witnesses, if any required.
  - Mail/courier applications:
- Power of attorney (POA) in original, Affidavit, Declaration, or other civil documents should first be attested by the local notary.
- Original + one copy of the Power of attorney (POA), Affidavit,
  Declaration, or other civil documents notarized must be brought to the
  BLS Centre along with the copies of
  'supporting documents.
- Download miscellaneous form, fill it completely, paste photograph and sign it. Attach filled in Misc form with photocopy of the original document/POA and self-attested copies of all supporting documents (passport, address and status proof of the executant.
   (s) in Canada). In case of joint PON/Affidavit/Document, all signatories have to fill Mise service form and should provide self attested copies of all supporting documents
- These two sets (original and copy), along with the required fee, can be mailed to the BLS Centre by the executant(s).
